## **The National Numeracy Leadership Council**

Independent charity National Numeracy has a clear mission: to improve how people understand and work with numbers in day to day life, sparking better opportunities and brighter futures.

We believe that a major shift in attitudes is key to this. So, in September 2021 National Numeracy joined forces with HM Treasury, the Department for Work and Pensions (DWP), and pioneering businesses to find new ways to tackle the stubborn problem of low numeracy.

Together, we formed the National Numeracy Leadership Council (NNLC), chaired by Andy Haldane, Chief Executive of the RSA and Vice-chair of National Numeracy.

We believe a numerate nation is crucial to improving outcomes for UK PLC. Poor numeracy is costing the UK as much as £25 billion a year. Improving the numeracy of the workforce has multiple positive effects. It increases access to jobs, supports workplace skills, promotes progression and drives financial inclusion.

The Council comprises senior leaders from Amazon, Amazon Web Services, Barclays LifeSkills, Bloomberg L.P, Capital One UK, Experian UK & I, KPMG UK, S&P Global, TP ICAP, Vanquis Banking Group plus HM Treasury and the DWP.

In 2023, Council members have worked to influence and effect positive, sustainable, systemic change as a group, within industries and in their own organisations. This has included shaping the education system, engaging policy makers, and consulting on national initiatives.

# The Skills Minister attends Council meeting

The Council was delighted to discuss local and national numeracy perspectives with the Skills Minister Robert Halfon MP. Among the topics raised were the adult numeracy initiative 'Multiply', the Lifelong Learning Entitlement, practical applications for numeracy in everyday life, dyscalculia and inspiring people to take their first steps with learning.



# 'Maths to 18' employer consultation: an industry perspective

consultation for the government's 'Maths to
18' initiative. They shared employer insights
to help guide its development, discussed how
it can best meet the employer needs and how
businesses can promote the scheme.

## 'Maths to 18' Advisory Committee

Council Member and Gender

Taskforce chair Lucy-Marie Hagues, CEO of Capital One UK and International, accepted a seat on the Prime Minister's eight-strong Maths to 18 expert advisory group. The government intends for young people to study mathematics to age 18, believing it will boost the knowledge and skills needed in the economy. The expert advisory group was tasked with collating evidence and providing advice on the maths young people need to study in a post-16 education system.

### **Consulting on National Initiatives**

#### The Royal Society's Mathematical Futures programme

In September, the Council was honored to become the first group of employers to be consulted on the Royal Society's Mathematical Futures programme, which aims to build a new vision of mathematics education.

During a fascinating session, Council members shared employer perspectives on current and forecast challenges in human resources, and agreed on an alignment with the Society's work to build the numerate nation we need in the future.



#### Future skills roundtable event

We were honoured that the former Lord Mayor of London Alderman Nicholas Lyons joined our breakfast roundtable event in the heart of the City. Founding Member S&P Global and Council Member Oliver Wyman convened 13 businesses to discuss the vital role numeracy plays in the UK skills landscape.

## Influencing the financial sector: high-profile positioning of the importance of numeracy and industry events

UK Finance is the collective voice for the banking and finance industry, representing more than 300 firms across the industry. At its North Dinner in Manchester, Capital One took to the stage to emphasise the crucial role of numeracy and the need for the sector to focus on it when supporting growth and skills development in the UK's regions.

Lucy-Marie Hagues, CEO, presented findings about numeracy levels in Manchester drawing on the UK Numeracy Index, created by National Numeracy and Experian.

Throughout the year, Council members have engaged business audiences and the general public with stories about the transformational power of numeracy for lives and livelihoods. From opinion pieces in the media, to engaging social media posts, the personal support and network reach of our Council members is influential in raising awareness of the numeracy crisis and inspiring others to get involved.





#### Nationwide political engagement

The Council businesses wrote to all MPs highlighting numeracy levels in each individual constituency and asking for support with National Numeracy Day, our charity's flagship campaign.

National Numeracy Day was supported by politicians on all sides of the house, with attendance at events and schools and promotion in the press and social media. The Prime Minister, Ministers, Shadow Ministers and government departments all got involved and the first ever National Numeracy Day Parliamentary debate was held.


